## Shell Discoverer Air Permit - Chukchi Sea

### Revised Draft Air Permit Proposed

**Summary:** EPA seeks public comment from July 6 to August 5 on revised draft Outer Continental Shelf (OCS) Prevention of Significant Deterioration air permits for Shell Gulf of Mexico Inc./Shell Offshore Inc. The revised draft permits will authorize air emissions from Shell's oil and gas exploration drilling in the [Beaufort Sea](#) and the Chukchi Sea. Shell will use the Discoverer drillship and a support fleet for oil and gas exploration drilling beginning in 2012 on the Beaufort Sea OCS, within and beyond 25 miles of Alaska's seaward boundary and on the Chukchi Sea OCS, 25 miles beyond Alaska's seaward boundary, as authorized by the [U.S. Bureau of Ocean and Energy Management and Regulatory Enforcement](#).

**Public Hearing:** A public hearing will be held **August 4, 2011** at the Inupiat Heritage Center in Barrow, Alaska. Teleconference is available at North Slope Borough teleconference centers.

**Information Meeting:** 5pm-6:30pm

EPA will accept comments on the 2011 revised draft air permits for Shell Gulf of Mexico Inc./Shell Offshore Inc. submitted during the public comment period and at the public hearing. Written and oral comments can be given at the public hearing in Barrow, Alaska. Communities outside of Barrow can participate in the public hearing by telephone at North Slope Borough teleconference centers. Written comments can be submitted by mail or email. Oral comments can also be recorded on tape, disk, or digital audio and submitted by mail or email.

EPA issued final air permits to Shell in 2010. The [Environmental Appeals Board](#) remanded the 2010 permits to EPA Region 10 for further consideration. EPA is proposing revised draft air permits to address the remand.

The Supplemental Statement of Basis supplements the Statement of Basis for the 2010 permits, and addresses the remand and changes requested by Shell, but generally does not address other aspects of the 2010 permits that are unchanged in the 2011 revised draft permits. EPA is accepting public comment only on those parts of the 2011 revised draft permits proposed for revision and the information and analyses supporting those revisions. If you believe any provisions of the 2011 revised draft permits proposed for revision or the information or analyses supporting those revisions are inappropriate, you may comment on the permits and raise all reasonably ascertainable issues and submit all reasonably ascertainable arguments supporting your position by the end of the comment period. Supporting documents must be included in full, not by reference, unless they are already part of the record for these permits, are state or federal statutes or regulations, EPA documents of general applicability, or other generally available referenced materials. Please identify whether your comments relate to the Chukchi permit, the Beaufort permit, or both. The 2011 revised draft permits are based on the Coupled Ocean-Atmosphere Response Experiment meteorological modeling algorithm and the Plume Volume Molar Ratio Method nitrogen dioxide modeling algorithm to predict air pollutant concentrations. These modeling algorithms have not been approved by EPA for general use, but have been approved under EPA guidelines case-by-case alternative modeling provisions and EPA Region 10 also requests public comment on the suitability of these modeling algorithms for these permits. **Comments must be postmarked or emailed to EPA Region 10 by August 5, 2011.**

We will consider all timely comments in making the final permits decisions. EPA will prepare a statement of reasons for changes made in the final permit and a response to comments received, and will provide commenters with notice of the final permit decision.

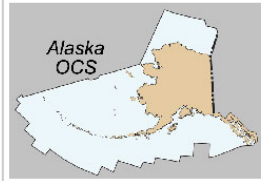
